CONSIGNORS CONTRACT: READ BEFORE SIGNING

I hereby consign the foregoing livestock (the Animal(s)) to San Antonio Horse Sale Company for sale in the designated Sale and inclusion in the Sale catalog subject to the following terms and conditions:

1. I warrant title to each Animal free from all adverse claims to ownership, use or possession and agree to defend title against all claims. I authorize you to advertise and sell each Animal at public auction, to make representation and warranties set forth in the Sale Conditions on my behalf, to deliver possession of each Animal to the highest recognized bidder, to transfer title thereto and to receive and disburse the proceeds of sale for my account.
2. I agree to pay you the designated Entry Fee for each Animal and agree that the Entry Fee will be deemed earned by you on the Withdrawal Date. I understand that I have the right to withdraw any Animal at any time prior to the Withdrawal Date and receive a refund of the Entry Fee by delivery of written notice to you. Effective on the Withdrawal Date, I agree that your authority to sell each Animal will be irrevocable and that each Animal will be offered at the Sale unless the Animal is excused by you; on such excused withdrawal, the Entry Fee will be retained by you. In the event any Animal is not offered at the Sale (unless withdrawn prior to the Withdrawal Date or thereafter excused by you), or in the event of my revocation of this Agreement after the Withdrawal date, I agree to pay you, on demand, as liquidation damages, the Entry Fee and the sum equal to twenty percent (20%) of: (i) the amount of the sale price, if such Animal has been sold; or (ii) the fair market value of such Animal as of the Sale date if such Animal has not been sold or the sale price cannot be determined to your satisfaction. A \$35.00 fee per horse will be assessed for all Entry Fees which are approved to be withheld from consignors sale proceeds.
3. In addition to the Entry Fee, I agree to pay you the designated Sales Commission on each Animal computed on the final recognized bid at the Sale, by whomsoever made, regardless of whether such Animal is or is not sold at such bid. You are authorized to deduct all sums owing to you, including sundry expenses (stall card, stall and initial bedding), from my account and in the event of any deficiency, I agree to immediately pay you the balance due.
4. I understand that you reserve the right to: (i) reject the entry of any Animal in the Sale at any time on return of the Entry Fee for such Animal; (ii) approve any assignment of my rights and obligations under this agreement; (iii) determine the order of sales of all Animals; (iv) assign stabling facilities subject to such stabling policies as you may establish; (v) examine each Animal and make such catalog corrections and announcements as you deem appropriate; and (vi) change the time, date or location of the Sale should circumstances, in your sole discretion, necessitate such a change.
5. I agree, at the time of entry, to deliver to SAHSC the following documents in form satisfactory to SAHSC with respect to each animal: (1) the original certificate of registration issues either by American Quarter Horse Association, American Paint Horse Association, Appaloosa Horse Club or the Jockey Club (or my certificate that all matters required by the applicable Breed registry have been furnished and issuance of the certificate of registration pending); (2) all transfer reports and other items required to transfer registration of the Animal to the buyer; (3) properly signed stallion service and breeders certificates for bred mares; Also, I agree to provide SAHSC a **NEGATIVE COGGINS** test dated **NO LATER** than one (1) year prior to the date the Animal sells; a health certificate dated **NO EARLIER** than twenty (20) days prior to the date the animal sells; and evidence, by a licensed veterinarian, of pregnancy status for any Animal represented to be bred or pregnant **NO MORE** than ten (10) days prior to the date the Animal sells. **I UNDERSTAND THAT SAHSC WILL WITHHOLD ANY MONIES DUE ME UNTIL ALL SUCH DOCUMENTS ARE DELIVERED TO SAHSC.**
6. **PAYMENT TO CONSIGNORS:**
 - A. Payment to our consignors will begin on the 21st banking day, or the 30th calendar day after the sale.
 - B. Registration Certificates will not be transferred until the buyers check has cleared the bank. Papers will be processed within 45 working days following the sale.
 - C. Payment to our consignors will be held until all necessary papers are in San Antonio Horse Sale Company offices.
 - D. **AN ASSESSMENT OF \$150.00 WILL BE CHARGED ON ANY PROBLEMS IN PROCESSING PAPERWORK.** I agree to provide such information as you might request with respect to the ownership, description, pedigree, produce, performance, health and conformation of each Animal. I understand that you will provide to me a copy of the Sale catalog prior to the Sale date setting forth my representations and warranties with respect to each Animal and I agree to review such catalog and promptly notify you of any corrections thereto.
7. I represent and warrant to the buyer and SAHSC of each Animal the following: (a) title to the Animal free from all adverse claims to ownership, use or possession, (b) the Animal is sound of eyes, (c) the Animal is not a "cribber," (d) the sex and condition as a gelding or ridgeling of the Animal is as described in the Sale catalog; (e) that there are no white markings that would affect registration; (f) the identity of the Animal as described in the Sale catalog; (g) that each Animal that is a Thoroughbred or Quarter Horse has been blood typed or had a genetic sample taken in accordance with the current rules and regulations of the applicable breed registry for the Animal; (h) that each Animal which is a Quarter Horse and foaled after December 31, 1991, has been "Parentage Verified" in accordance with the current AQHA'S rules and regulations; (i) as to Animals of racing age, the Animal is not at the time of sale on any starter's, steward's or track veterinarian's list. For foals under 90 days of age, the consignor's obligation under clauses (g) and (h) will be satisfied if the consignor has submitted all necessary samples to the appropriate breed registry and a Parentage Verified registration certificate is issued for the Animal within a reasonable period of time not to exceed ninety (90) days.
8. I agree to deliver each Animal f.o.b. the Sale location not later than 6:00 P.M. local time on the day before the anticipated Sale date. I understand that the maintenance of each Animal is my responsibility until sold and I agree to care for each Animal while stabled on the Sale premises in accordance with approved husbandry practices and your stabling policies. On my failure to so care for any Animal, I agree that you may, at your option, undertake such care and I agree to reimburse you for all expenses of stabling, feed, veterinary care, transportation and maintenance of any Animal. I agree that you will not incur any liability whatsoever for the loss, damage, death or illness of any Animal.
9. I understand that you will use reasonable efforts to verify the financial responsibility of the buyer of each Animal and the possession of each Animal sold will be released to the buyer against receipt of future payment after satisfaction of your Settlement Procedures. I agree that if the sale of any Animal is not consummated by reason of the default of the buyer or otherwise, you shall not be liable for the purchase price of the Animal and your sole obligation shall be to assist me in the collection of the purchase price of the Animal, recovery of the Animal or resale of the Animal at the Sale or by private sale to the extent that I might request. I understand that you do not guarantee the validity, enforceability, payment or collection of any instrument delivered to you in payment of the purchase price of any Animal. Any obligation which you might owe to me by reason of a buyer's default will be discharged by your resale of the Animal by public or private sale, whether or not the resale price equals the price agreed to by the defaulting buyer.
10. I agree to indemnify and hold you harmless from all claims, expenses and costs (including, without limitation, attorney's fees) arising out of: (i) any question of title to or my authority to sell any Animal; (ii) any lien, attachment or claim asserted against any Animal or the proceeds of sale; (iii) any claimed default in my representations or warranties with respect to any Animal; (iv) loss or damage to property and injury or death of persons caused directly or indirectly by me, my agents or employees or any Animal; (v) my entry or sale of any Animal; or (vi) my default in performance hereunder. I agree to pay you, on demand, the full amount of any loss which you may incur in settlement of any claim or demand on account thereof.
11. I understand that the terms of the Sale Conditions and Settlement Procedures published in the Sale catalog will govern the sale of each Animal and I hereby approve the same and agree to be bound thereby.
12. This agreement will be binding on me, my heirs, personal representatives, successors, permitted assigns, any successor in ownership of each Animal and will inure to the benefit of your successors and assigns. I have read and approved the foregoing terms and conditions.
